## Order

**Subject: Composition of the Scientific Committee and Scientific Panels - reg.**

The Food Authority, in exercise of powers vested in it under Section 14 and 13 of the FSS Act, 2006, approved the reconstitution of the Scientific Committee, and reconstitution of Scientific Panels in its meeting held on 30<sup>th</sup> October 2012. The composition of the Scientific Committee was issued vide Order dated 26<sup>th</sup> March, 2013 and the composition of the Scientific Panels was issued vide Orders dated 5<sup>th</sup> February, 2013 and 18<sup>th</sup> March, 2013 respectively. The constitution of Scientific Committee and the Scientific Panels was for a period of three years from the date of issue of orders in terms of provisions contained in Section 15 of the FSS Act, 2006.


