

Prevention of Food Adulteration (1st Amendment) Rules, 2009.

NOTIFICATION

New Delhi, the 22nd January, 2009

***G.S.R. 42(E).**— The following draft of certain rules further to amend the Prevention of Food Adulteration Rules, 1955, which the Central Government, after consultation with the Central Committee for Food Standards, proposes to make, as required by sub-section (1) of section 23 of the Prevention of Food Adulteration Act, 1954 (37 of 1954), is hereby published for the information of all persons likely to be affected thereby; and notice is given that the said draft rules will be taken into consideration after the expiry of a period of sixty days from the date on which copies of the Official Gazette in which this notification is published, are made available to the public;

Objections and suggestions, if any, may be forwarded to the Secretary, Ministry of Health and Family Welfare, Government of India, Nirman Bhawan, New Delhi – 110011;

The objection and suggestions, which may be received from any person with respect to the said draft rules before the expiry of the period so specified will be considered by the Central Government.

DRAFT RULES

1. (1) These rules may be called the **Prevention of Food Adulteration (1st Amendment) Rules, 2009.**

(2) They shall come into force on the date of their final publication in the Official Gazette.

2. In the Prevention of Food Adulteration Rules, 1955, for rule 48-C, the following rule shall be substituted, namely :—

“48-C. Sale of food additives.— The food additives mentioned in column (2) of the Table given below, permitted for use in certain foods, shall conform to Bureau of Indian Standards specification mentioned in column (3) of the said Table, as amended from time to time, namely :-
