**NOTIFICATION**

New Delhi, the 6th February, 2006

**\*G.S.R. 51(E).**— In exercise of the powers conferred by sub-clause (ii) of clause (e) of section 3 of the Insecticides Act, 1968 (46 of 1968), the Central Government, after consultation with the Central Insecticides Board, hereby includes the following substances in the Schedule to the said Act, namely:—
