Whereas the draft of the Food Safety and Standards (Contaminants, Toxins and Residues)

(Amendment) Regulations, 2015 were published as required under sub-section (1) of section 92 of the Food

Safety and Standards Act, 2006 (34 of 2006), vide notification of the Food Safety and Standards Authority

of India number F.No P. 15025/264/13-PA/FSSAI dated the 9th April, 2015 in the Gazette of India,

Extraordinary, Part III, Section 4, inviting objections and suggestions from the persons likely to be affected

thereby, before the expiry of the period of thirty days from the date on which the copies of the Official

Gazette containing the said notification were made available to the public;

And whereas the copies of the said Gazette were made available to the public on the 9th April, 2015;

And whereas the objections and suggestions received from the public in respect of the said draft

regulations have been considered by the Food Safety and Standards Authority of India;

Now, therefore, in exercise of the powers conferred by clause (i) of sub-section (2) of section 92 read

with section 20 and 22 of the said Act, the Food Safety and Standards Authority of India hereby makes the

following regulations further to amend the Food Safety and Standards (Contaminants, Toxins and Residues)

Regulations, 2011, namely:-

Regulations

1. Short title and commencement.- (1) These regulations may be called the Food Safety and

Standards (Contaminants, Toxins and Residues) (Amendment) Regulations, 2015

(2) They shall come into force on the date of their publication in the official Gazette.

- 2. In the Food Safety and Standards (Contaminants, Toxins and Residues) Regulations, 2011, in regulation 2.2 relating to "Crop Contaminants and naturally occurring toxic substances", in sub-regulation 2.2.1, for clause in clause 1 and the table thereunder, the following shall be substituted, namely:-
- "1. No article of food specified in column (3) of the Table below shall contain any crop contaminant specified in the corresponding entry in column (2) thereof in excess of quantities specified in the corresponding entry in column (4) of the said Table:
