Whereas the draft Food Safety and Standards (Food Products Standards and Food Additives) (Amendment) Regulations, 2014, were published as required under sub-section (1) of section 92 of the Food Safety and Standards Act, 2006 (34 of 2006), vide notification of the Food Safety and Standards Authority of India number F.No P. 15025/261/2013-PA/FSSAI dated 5th December, 2014 in the Gazette of India, Extraordinary, Part III, Section 4 inviting objections and suggestions from the persons likely to be affected thereby, before the expiry of the period of thirty days from the date on which the copies of the Official Gazette containing the said notification were made available to the public;

And whereas the copies of the said Gazette were made available to the public on the 5^{th} February, 2015:

And whereas the objections and suggestions received from the public in respect of the said draft regulations have been considered by the Central Government;

Now, therefore, in exercise of the powers conferred by clause (e) of sub section (2) of section 92 read with section 16 of the said Act, the Food Safety and Standards Authority of India hereby makes the following regulations further to amend the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, namely:-

Regulations

- 1. (1) These regulations may be called the Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2014.
- (2) They shall come into force on the date of their final notification in the Official Gazette.
- 2. In the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, in Appendix A, relating to "list of food additives", in Table 1 relating to List of food Additives for use in bread and biscuits, in serial number B, against item 7, relating to column 4, for the symbol "-", the letters "GMP" shall be substituted.
